Approval of Minutes

A motion to approve the Board of Directors meeting minutes held March 27, 2024 was made by M. Fiacco seconded by E. Sears, all in favor, motion carried, minutes approved.

Secretary Report

J. Gilbert reported on community communications.

An email received from a resident to ask if operational expenses are outlined for the marina in the same way as other expenses and if so, was requesting a copy.

The May 18, 2024 Budget meeting notice was sent to the community.

An email request to put a kayak and longboard down at the marina.

A letter sent to a resident regarding dangerous branches hanging from a tree located on their property.

A response email received from the resident regarding hanging branches stating that they would address the issue.

An email request received for a 2024 Marina Map.

An email received from a resident stating that the basketball light shines into their windows and is on continuously. In addition, a question regarding the position of the proposed camera at the Beach noting the concern of privacy.

A response email was sent to the resident advising that the proposed electrical work would address the light as it would be on a timer in a secure location. In addition, the camera would be positioned on the basketball court and parking area.

A followup email from the resident was received related to the camera position which will be addressed with the security company upon installation.

Treasurer Report

M. Fiacco provided an updated financial review.

We continue to receive overdue taxes resulting from the efforts of new bookkeeper. M. Fiacco is working with Union Saving to investigate the possibility of tax bill payment directly at the bank.

She provided updated copies of the budget proposal along with modeling examples for board review. Hand outs will be available to the residents at the budget meeting.
